In the matter of personal service of "Notice to Surety of Defendant's Failure to Appear" - MCL 765.28

1. MCL 765.28 requires that in criminal cases wherein the defendant has posted a surety bond as bail and fails to appear for a court proceeding, the court is required to provide the surety with prompt notice of the defendant's failure to appear; and,
2. MCL 765.28 requires that such notice by either personal service or leaving the notice at the surety's last-known business address;
3.
