CHAIR GEIGER AND COMMISSIONER GIBSON - Request to Reconsider the Name of the Cabinet Building.

Discussion followed for a process where residents can submit alternative names for the Cabinet Building, and vote on those names. There was a consensus to allow 30 days for public input.

Chair Geiger stated that the Board would work with Administration on a publication to invite the public to participate in choosing a name for the county's new community building presently known as the Cabinet Building.
